



Trade Promotion: Family Day Care Perception Survey Competition

Conditions of Entry

Entry into this Competition confirms acceptance to these Conditions of Entry, so entrants should read and fully understand them prior to entering the Competition.

1. Details of Promotion

- Information on Entry into the Family Day Care Perception Survey Competition (“Promotion”) forms part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- The Promotion commences at 00:01 AEST on Thursday 11 May 2023 and entries close at 23:59 AEST on Sunday 4 June 2023 (“Promotion Period”).
- Entries not received by 23:59 AEST on Sunday 4 June 2023 or not completed in accordance with Entry Procedure will not be eligible to win.

2. Who can enter

- Entry is open to individuals who have completed the Family Day Care Australia (FDCA) Family Day Care Perception Survey.
- Employees (and their immediate families) of Family Day Care Australia and agencies or organisations associated with this Promotion are ineligible to enter. “Immediate families” means any of the following: spouse, ex-spouse, de-facto spouse, ex-defacto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, grandchild, step-grandchild, brother, sister, step-brother, step-sister, whether or not they live in the same household as the director, manager, employee, officer or contractor.
